### 2008-2009 Financial Regulations

1. Registration Fee is non refundable and is payable upon initial registration.
2. Capital Assessment is non refundable and is generally payable upon initial registration.
3. The tuition fee covers all school related expenses such as books, instructional materials and laboratory fees.
4. Tuition Due Dates: Capital Assessment & Registration Fee – upon receipt  
Semester I – Monday, July 7, 2008  
Semester II – Wednesday, December 10, 2008  
A student may not be permitted to attend classes unless fees due have been paid in full.  
Any exception from this provision must be obtained in writing from the Head of School.
5. Re-registration: A € 500 advance on tuition is required to hold a returning student's place for academic year 2008-2009 by Thursday, April 10, 2008. A late re-registration fee of € 500 will be applied for a late re-registration.
6. Cancelled Re-registration: 50% of the advance is refundable if notification is received by July 3, 2008.
7. Installment Plan: The AOSR installment plan will incur a fee of € 300. This plan divides the yearly tuition fee into four payments, due on or before the following dates:  
July 7, 2008                      October 2, 2008                      January 8, 2009                      March 5, 2009
8. A late charge of 1% per month will be applied to late payments. Delinquent accounts may result in the dismissal of the student.
9. Late enrollment: Tuition and transportation costs for students admitted before the Mid semester dates (see below) must be paid in full for that semester; otherwise, the semester cost will be determined on a case-to-case basis, based upon previous school transcript credits and other documentation.  
Mid semester I – October 30, 2008                      Mid semester II – April 2, 2009
10. Early withdrawal: The school will not reimburse any payments for a current semester because of a student's absences, withdrawal, suspension or expulsion. However, semester II payments will be reimbursed if the school is notified of a transfer by Wednesday, January 7, 2009. Official transcripts and records are released after all financial obligations are met.
11. Financial aid may be granted on an individual basis. Financial aid is considered for students whose parents or guardians give demonstrable evidence of financial need. Financial aid application forms can be acquired from the Billing Office ([billing@aosr.org](mailto:billing@aosr.org)).
12. Bus Service: School bus routes are arranged to provide as convenient a service as possible. AOSR reserves the right to alter routes and times during the school year.
13. Lunch costs are not included in the tuition fees but are complimentary for students in Pre-K through Grade 3. Starting at Grade 4, lunches are *à la carte*. Pre-paid student lunch cards are used to pay the caterer.
14. Payments may be made in cash (Euros) or check (Euros or Dollars) or wire transfer (Euros or Dollars).  
Checks are made payable to: AMERICAN OVERSEAS SCHOOL OF ROME.

For bank transfers, be sure to include the reason for the payment and the student's last name for whom payment is made.
